#### LETTER FROM THE PRESIDENT

November 28, 2021

My Dear LCA-DC Community,

We have come to the end of our first year since taking over the reins of the Liberian Community Association of the Washington DC Metropolitan Area (LCA-DC) November 7, 2020. Challenges of COVID-19, such as, closure of community centers, and closure of meeting halls, and curtailed visits with our elderly had to be overcome.

The LCA-DC Executive Council, still "gathered" for a Planning Retreat in 2020, two General Assembly meetings, a Black History Month Program and a series of events to mark the 174th Independence of Liberia as a major fundraising program. Our COVID Task Force fed underprivileged youth in Liberia and are



planning much more. During this year, the LCA- DC community became stronger as we faced the reality or the times.

The Ways, Means and Finance Committee took the lead in ensuring that payments to our organizations go directly into an LCA-DC bank account, avoiding a need for officers to accept payments personally. The establishment of our associations' CashApp, PayPal or Zelle accounts has help to increase accountability and transparency in the management of the organization's finances. The second major step taken by the Finance team is the drafting of Financial Procedures that we expect will be incorporated into our By-Laws. The financial stability of the LCA-DC rests with over \$12,000 in our account today.

LCA-DC was represented at ULAA's 2021 Convention in Ohio by more than 50 delegates. We participated on a panel advocating against sexual violence organized by HEAL. We visited several Liberian churches in the DMV, we awarded community members who achieved academic and other milestones, we attended funerals of our ascended hero/heroines. We serve on the 2022 Bicentennial Anniversary Committee in the USA to commemorate the landing of the settlers in Monrovia in 1822. We continue to make strides in establishing a Community Center. We plan to do much more. We will deliver winter scarfs, hats and gloves to our elderly in the community. Finally, we partnered with Kimbeline Youth for Jesus Christ, and the Ministry of Health on the fight against COVID in Liberia during which we stumbled on a population of underprivileged youth (Zokos) who live in graveyards in Liberia. Their needs are basic, beyond vaccination—they ask for food, food, food!—so we have helped to feed them before being vaccinated. Together we can do more.

Thank you, Members of our General Assembly, the backbone for keeping LCA-DC STRONG!



#### **ACTIVITIES/PROGRAMS/PROJECTS**

This Annual Report provides the LCA-DC General Assembly with an overview of activities over the past 12 months, in accordance with Article V, Section 2 (c) of the LCA-DC Constitution, which requires that undertakings of the Association be reported in the months of November, February, May and August. This Annual Report also provides a roadmap of activities for the coming year.

#### Plan of Action Retreat

Our year began with a PoA Retreat to chart the course of activities for the year. The Retreat broke out into seven groups focused on: Community Center, Education; Health; Programs; Finance; Social Media and Membership. Each group formed committees that drafted activities in their respective areas. The PoA was presented to the General Assembly for approval. Due to COVID-19 pressures, the Executive Council focused on aspects of the PoA that could be implemented under the circumstances.

#### **Black History Month**

LCA-DCA hosted a virtual Black History Month themed "Celebrating Liberia's Role in Black History" on Zoom. The newly elected Executive Council was inducted into office by The Reverend Canon John Harmon. Several speakers graced the occasion including: Ambassador George Patten; Dr. Douglas Layton; ULAA President, Vamba Fofana; BoD Chairman, Isaac Karto; and HBoG Chairman, Steven Koffa; Rania Fawaz sang "Lift Every Voice and Sing," accompanied by M.P. Weeks, and Hilary Stryker sang "The Lone Star Forever."

Liberia's 174th Independence Celebrations: Festival, Zoom Panel, Awards & Ball

The LCA-DC Program Committee hosted and participated in a series of programs marking the 174<sup>th</sup> Independence of Liberia.

A **Thanksgiving Service** organized by the Association of Liberian Christian Ministers headed by Rev. John Orlando Flahn kicked of the 2021 '26 season. President Redd made remarks at the service attended by the VP John Pearson, Vice HBoG Chair Rena Jarrett Smith, and BoD Chairman, Isaac Karto held at Our Savior Lutheran Church on July 18.

LCA-DC organized the "One Liberia" Festival, in partnership with the All Liberian Network, on the grounds of the Liberian Embassy on July 24. Vendors sold food,




Figure 7: Current President rt & Former President Lucy Wilson-Kear, Ift.

#### LCA-DC COVID-19 TASK FORCE

After the July events had generated funds, the LCA-DC had to make good its promise to utilize some of the funds raised during the 174<sup>th</sup> '26 programs on a project to reduce the spread of COVID, which was wreaking havoc in Liberia at the time. In August 2021 the President utilized her personal funds, traveled to Liberia and met with the Minister of Health to find the most useful way

to help bring the spread of COVID to an end. It was determined that getting people to take the vaccinations was the most relevant approach. The President also met with Evangeline Israel King, head of the Kimberline Youth for Jesus Christ who works with underprivileged youths. The President agreed with the COVID Task Force to facilitate the vaccination of so-called Zokos. In September, the Dr. Katherine Redd, member of the Task Force as well as the Health and Wellness Committee visited Liberia, also funding herself, and was escorted into the

graveyard at Thinkers Village near ELWA. A virtual meeting was held with those who she met and they presented the dire needs in their population which is growing into the thousands around Monrovia. The Task Force provided food for two ghetto communities and fed close to 500 persons. The goal is to get them vaccinated after they eat some nourishment and provide them with t-shirts.

LCA-DC plans to raise funds to vaccinate these youth, feed them and facilitate their rehabilitation so that they leave the graveyard and become productive citizens. We will work with

organizations in Liberia to accomplish this.

#### PLAN OF ACTION 2022

The primary goal of the LCA-DC PoA is to develop a road map of activities for 2022 and identify budget resources needed to complete them. A detailed PoA is attached as an addendum for consideration by the GA. All Committees representatives will streamline the PoA in a Retreat in January after the GA accepts the broad outline. The objectives set forth are to:

- 1. Visit the elderly in homes around the DMV and give them winter accessories
- 2. Organize the 175th Independence Anniversary as a major fundraiser
- 3. Promote the Bicentennial celebration
- 4. Organize General Assembly and other meetings as required by the Constitution
- 5. Execute a major fundraiser for the COVID Task Force, and other targets
- 6. Increase membership participation and support
- 7. Make efforts towards a Liberian Center

#### **RECOMMENDATIONS:**

The Executive Council recommends that this GA achieves the following:

- 1. Accepts the PoA as a work in progress, while allowing the Executive Council to begin working towards its goals immediately
- 2. Accepts the budget of \$40,000 with an expectation that most of it will be recuperated during various fundraising events
- 3. Allow the Executive to make adjustments to the PoA and Budget based on the outcome of the Retreat


